PUBLIC ORDER OF DISCIPLINE

On October 28, 2010, the Disciplinary Board of the Hawai'i Supreme Court ("Board") imposed a Public Reprimand upon Steven H. Cedillos ("Respondent") based upon the record herein. This Order is being published pursuant to Disciplinary Board Rule 27 (DBR).

The record herein reflects that this matter was considered by the Board at its duly scheduled meeting on July 29, 2010. The Board reviewed and considered the Stipulation of Facts, Conclusions of Law, and Recommendation for Discipline filed on June 28, 2010, and also the information presented to the Disciplinary Board by Petitioner and Respondent.

Based on its review, the Board concluded and ordered the following:

- 1. That the Stipulation of Facts and Conclusions of Law filed on June 28, 2010, be accepted and adopted by the Board as the Board's Findings of Fact and Conclusions of Law.
- That the Recommended Discipline filed on June 28,
 be accepted and adopted by the Board, the Board having

determined that a Public Reprimand was the appropriate sanction for Respondent's professional misconduct.

- 3. That Respondent submit to the Board for approval and publish in the Hawai'i Bar Journal a written apology to the legal profession and the public and take and pass the Multi-State Professional Responsibility Examination.
- 4. That pursuant to Rule 2.3(a)(4) of the Rules of the Supreme Court of Hawai'i (RSCH) and DBR 27, the Board may impose a Public Reprimand upon Respondent with the consent of Petitioner and Respondent.
- 5. Respondent shall reimburse the Disciplinary Board all costs relating to this proceeding pursuant to RSCH 2.3(c).

This Order shall constitute a permanent record of the imposition of the foregoing PUBLIC REPRIMAND upon Respondent. Petitioner shall forthwith provide appropriate public notice of this Order.
